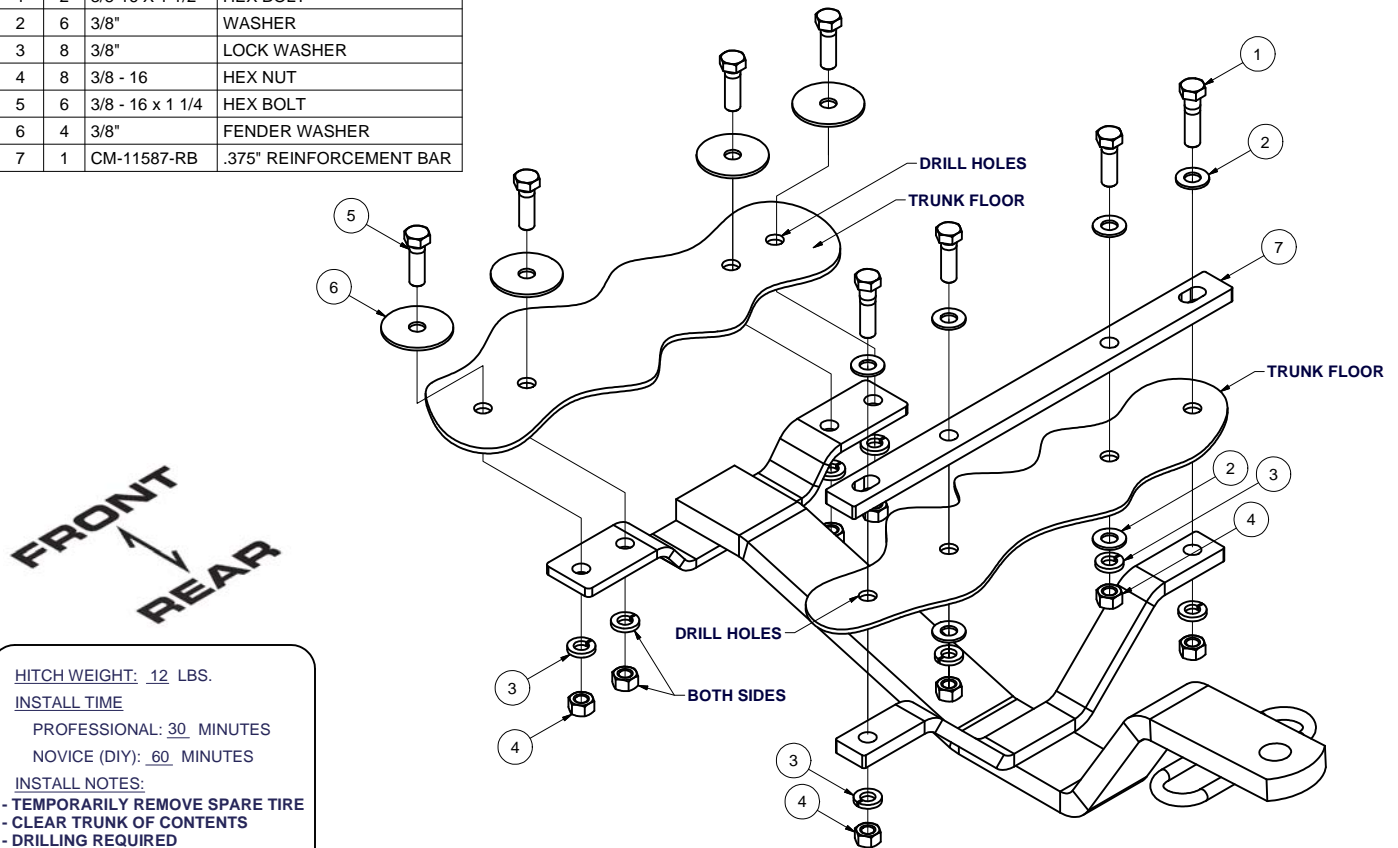

INSTALL NOTES:

- TEMPORARILY REMOVE SPARE TIRE
- CLEAR TRUNK OF CONTENTS
- DRILLING REQUIRED
- SILICONE AROUND FASTENERS

**INSTALLATION STEPS**

1. Remove the vehicle's spare tire and other contents. This hitch fastens to vehicle trunk floor with trunk reinforcement bar (CM-11587-RB) placed inside the trunk. Locate and mark centerline across vehicle at underside of trunk.
2. Position the hitch on underside of floor centered with the vehicle. The hitch should fit fore-aft on the vehicle so the trunk reinforcement aligns with rear bracket and "sandwiches" floor with reinforcement bar (CM-11587-RB) close to the rear of the trunk.
3. Use the hitch a template mark and centerpunch floor for (8) holes for 3/8" fasteners.
4. Install hitch with reinforcement bar (CM-11587-RB) and fender washers inside the trunk as shown.
5. Torque all 3/8" fasteners to 30 lb-ft.
6. Use silicone sealant around fasteners to seal out water and exhaust vapors.
7. Re-install spare tire and trunk contents.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
