

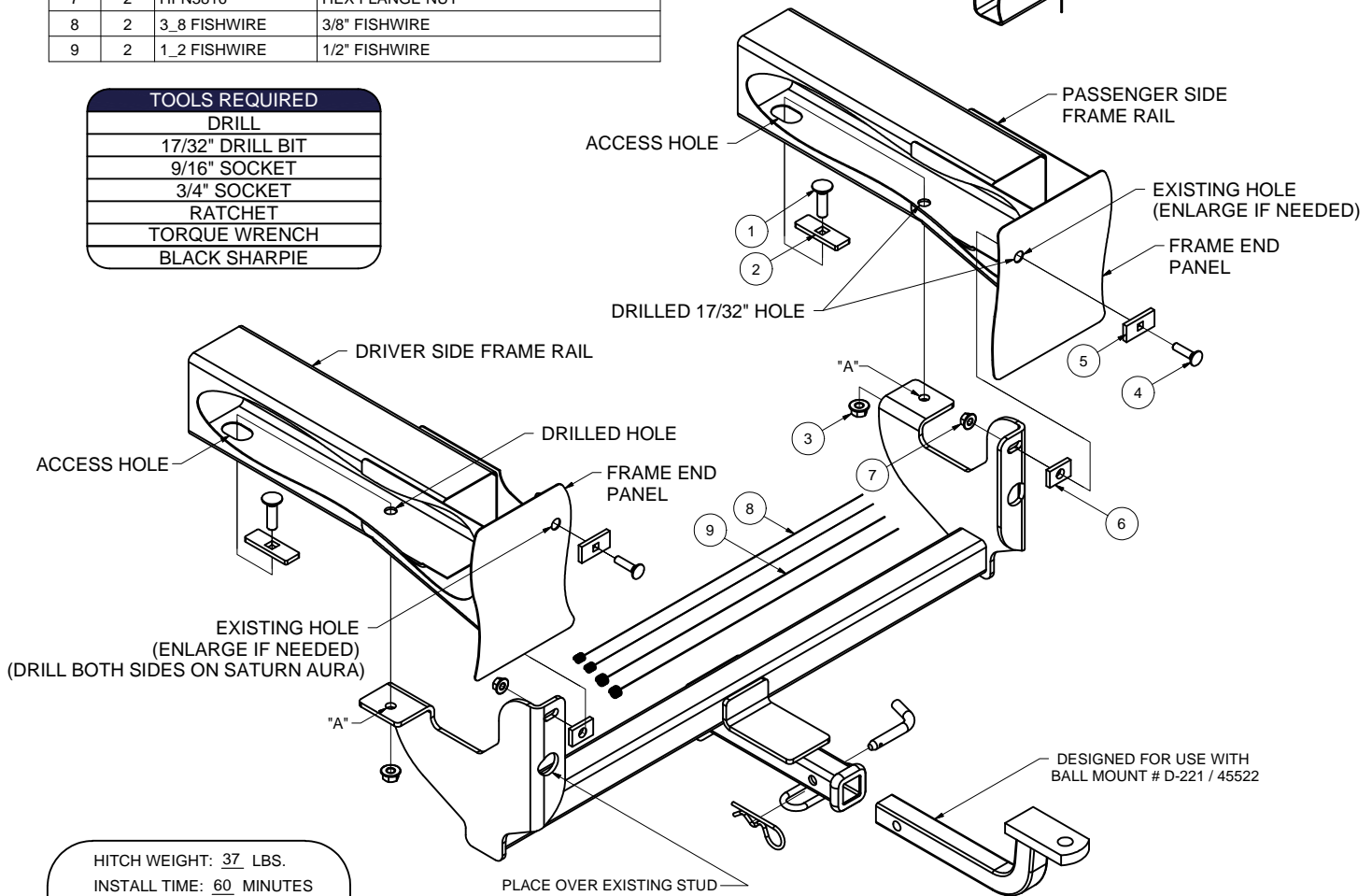
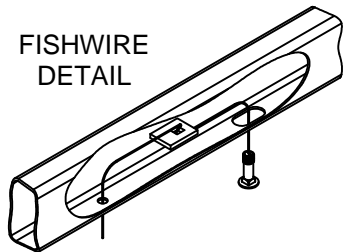

 INSTALL NOTES:
 - DRILLING REQUIRED
 - FISHWIRE HARDWARE

- Vehicle needs to be jacked up if installation is from ground level.
 - On models with dual exhaust, lower the exhaust to ease installation.

INSTALLATION STEPS

1. Feed fishwire through end panel. Slide spacer (Item 5) onto fishwire then thread carriage bolt (Item 4) onto fishwire. Gently pull spacer plate and carriage bolt into position. Thread spacer (Item 6) onto fishwire. Leave fishwire attached to carriage bolt to hold parts in position.
2. Raise the hitch into position and secure with hex flange nuts (Item 7).
3. Using the hitch as a template, drill one 17/32" hole thru each frame rail as shown.
4. Feed the fishwire through the hole in the hitch side plate ("A"), the drilled hole in frame rail and out the access hole in the frame rail.
5. Thread spacer (Item 2) onto fishwire, attach to carriage bolt (Item 1). Pull fasteners through slot & into position as shown.
6. Loosely install hex flange nuts (Item 3) onto carriage bolts.
7. Torque all 3/8" fasteners to 30 lb-ft and torque all 1/2" fasteners to 75 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
