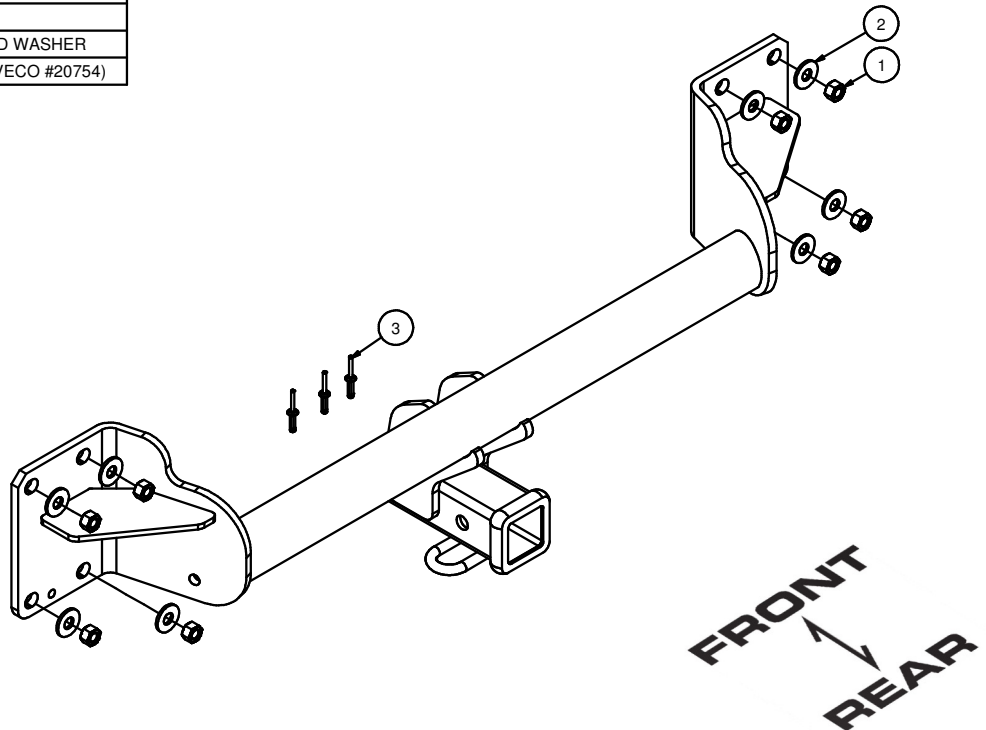

INSTALL NOTES:

- FASCIA TRIMMING REQUIRED
- NO DRILLING REQUIRED
- REMOVE LOWER BUMPER FASCIA
- REMOVE BUMPER

INSTALLATION STEPS

- 1) Remove 3 rivets from lower bumper fascia, and gently pull back molding to locate and remove bottom bolt.
- 2) Remove the bolts located behind each of the reflectors, the reflectors have to be removed.
- 3) Remove the 6 bolts located on the bottom of the bumper.
- 4) Open the bottom tailgate to 45° to access tabs, pull apart tabs by squeezing tabs and lifting out.
- 5) Gently pull bumper ends outward and push the bumper forward.
- 6) Remove steel bumper beam and fasteners, return to vehicle owner.
- 7) Locate hitch into position and install with supplied fasteners as shown.
- 8) Torque all 12mm fasteners to 82 lb-ft.
- 9) With hitch on vehicle, mark bumper fascia and trim until fascia fits back onto vehicle without interfering with hitch.
- 10) Reinstall bumper fascia onto vehicle.

NOTE: OEM tow hooks can no longer be used at rear of vehicle.**PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.**
