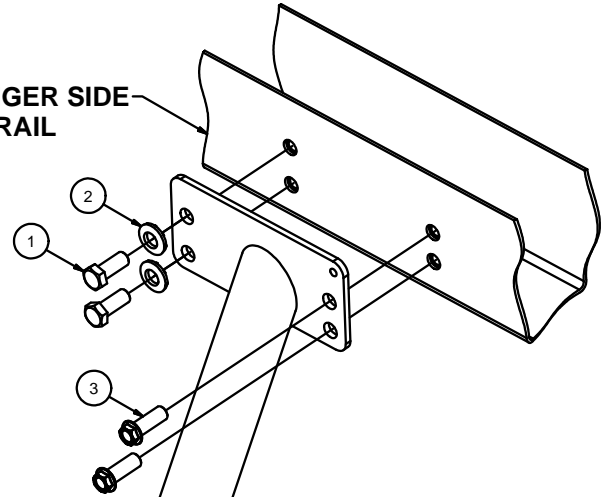

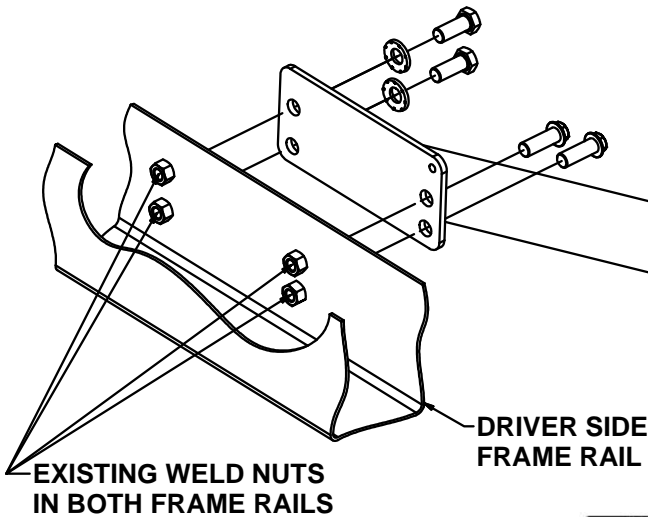

FRAME RAIL

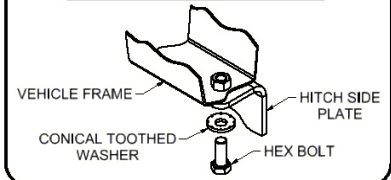


FRONT

ORIENTATION DIAGRAM

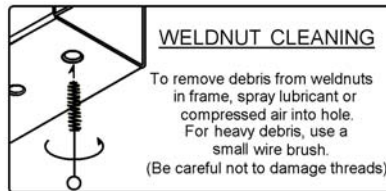


HITCH WEIGHT: 28 LBS.

INSTALL TIME: 30 MINUTES

INSTALL NOTES:

- NO DRILLING REQUIRED
- LOWER SPARE TIRE AND EXHAUST
- REMOVE / RE-INSTALL HEAT SHIELD



INSTALLATION STEPS

- 1) Remove the muffler hanger to allow the exhaust to drop down. Remove spare tire and muffler heat shield to ease installation.
Note: Retain heat shields and hardware for re-installation.
- 2) Raise hitch into position between frame rails and install fasteners as shown above.
- 3) Torque all 14mm fasteners to 101 lb-ft.
- 4) Re-install heat shield and spare tire (if removed), and re-attach muffler hangers.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
